St. Martin made a motion to approve the application with the 5 Conditions of Approval, as follows: 1) all erosion and sedimentation control measures installed and inspected prior to all excavation/grading on the site; 2) the applicant shall post a \$750 financial surety with the Town for erosion and sediment control measures; 3) the applicant shall delineate and protect all wetlands areas during construction, from intrusion of all construction equipment except as detailed on the approved site plan (where disturbance has been permitted) as part of this application; 4) a final as-built of improvements (dimensional sketch) shall be submitted to the Commission to add to the file; and 5) that all costs associated with the review and processing of the application, including inspection during construction, shall be paid in full by the applicant prior to the certificate of occupancy. J. Bergendahl seconded. All in favor.
- 6. CITIZEN'S COMMENTS: Jason Collins of 74 Wrights Crossing Road told the commission that he purchased 50 Wrights Crossing Road, with plans to build a 4-bedroom home on this lot. Jamie told Jason that he would need to show the wetlands on his plans. D. St. Martin if any test pits were done. Jason said they were done in 2020. He is looking for suggestions as to what he needs to do to get an approval. He's not building a house he wants approval and will put the lot up for sale. The commission members looked at the plans he had. D. St. Martin suggested that he have KWP look at the plans regarding the sewer. R. Brais also mentioned that he needs to put the flood zone on the plans.
